RE: ISSUE OF PERFORMANCE RIGHTS TO EMPLOYEES

Please find **attached** an Appendix 3B in relation to the issue of 778,963 Performance Rights to various employees of Mermaid Marine Australia Limited (**Company**+).

The Performance Rights represent an initiative on behalf of the Company to encourage its employees to improve the longer term performance of the Company and its returns to shareholders.

The key terms of the Performance Rights that have been issued are as follows:

- The Performance Rights have been issued for nil consideration.

 - total shareholder return relative to a selected peer group of companies over a period of 3 years from 1 July 2010 to 30 June 2013.
- Unvested Performance Rights lapse on cessation of a holderop employment with the Mermaid Marine Group.
- Any Performance Rights that do not vest at the end of the Performance Period (30 June 2013) will lapse.
