MMA OFFSHORE LIMITED (ASX CODE: MRM) – COMPLETION OF DISPATCH OF RETAIL OFFER BOOKLET

MMA Offshore Limited (**MMA**) refers to its earlier announcement on Wednesday, 11 November 2020 about its fully underwritten equity raising to raise up to \$80 million (**Equity Raising**), by way of a placement to certain institutional and sophisticated investors and a 1 for 0.475 non-renounceable entitlement offer to existing shareholders (**Entitlement Offer**).

The retail component of the Entitlement Offer (**Retail Entitlement Offer**) opened today (Wednesday, 18 November 2020) and is scheduled to close at 5.00 pm (Sydney time) on Friday, 27 November 2020.

Only eligible retail shareholders on the record date (being 7.00 pm (Sydney time) on Friday, 13 November 2020 may participate in the Retail Entitlement Offer.
